Job Description

Title: Quality Assurance Technician

Reports to: Quality Assurance Supervisor

Purpose:

Sto Corp. (Sto), a global innovation leader of façade insulation (EIFS) and high performance coatings, is seeking a Quality Assurance Technician. The ideal candidate will be responsible for performing testing on all incoming raw materials and finished goods ensuring that our customers receive the highest quality products. This role will also provide support to other manufacturing operations outside of the lab, as the workload allows.

Essential Duties & Responsibilities (includes, but not limited to):

- Test incoming raw materials and outgoing finished goods to verify that they meet Sto specifications and fall within process capability
- Maintain SAP quality data, provide usage decisions and recommend adjustments based on historical data
- Read and interpret statistical process data to improve manufacturing processes
- Contribute as needed to help maintain Plant Hygiene program
- Complete reports including Statistical Process Control charts, project status summaries or ISO work instructions
- Maintain all lab equipment including calibrations as scheduled
- Write and maintain clear and understandable Job Procedures for the Quality Assurance testing process in ISO 9000 work instruction format
- Maintain clean working environment including clear work surfaces, clean and wellmaintained equipment, clearly labeled storage areas, etc.
- Support product scale-ups and modifications by occasionally watching production batches and ensuring adherence to established work instructions and recipes.
- Participate in customer complaint and non-conforming product investigations and provide corrective actions as needed.
- Support Production and Receiving functions as needed
- Follow and comply with all safety policies, plant work rules and regulations.
- Other duties as assigned
