**Summary:**

Sto Corp. (Sto), a global innovation leader of building enclosure systems and high-performance facade coatings, is seeking a skilled **Production Supervisor** for the façade brick and wood products operation. The Production Supervisor oversees daily manufacturing operations and a team of production personnel to ensure efficiency, quality, and safety standards are met. This hands-on role is responsible for monitoring key process control metrics, identifying production bottlenecks, and implementing data-driven corrective actions to continuously improve process stability and output.

**Essential Duties & Responsibilities (includes, but not limited to):**

- Oversee Specialty Production Operation
  - Scheduling, planning, and production execution
  - Product tinting and color control
  - Quality control to ensure product quality is maintained throughout production
  - Inventory control of raw materials and finished goods
  - Training of specialty application techniques to workforce
  - SAP process for all facets of the operation
  - Improve production efficiencies, product quality, safety of the processes and reductions in operating expenses
  - Prepare finished goods for shipment
- Supervise staff, including full-time and supplemental employees on standard operating procedures (SOPs), quality control standards, and process improvement techniques.
- Understands and will ensure compliance with occupational health and safety policies and procedures.
- Experience with ISO-9000 & ISO-14000 QM/EM systems is preferred.
- Performs other duties as assigned.

**Education & Experience:**

- High school diploma or equivalent required. Associate's degree in a technical field (e.g., Industrial Engineering, Manufacturing) is preferred.
- 2 years of proven experience as a production or manufacturing supervisor, preferably in a process-driven environment.

- 4-6 years of hands-on production or manufacturing experience in a fast-paced industrial manufacturing environment.
- Fork-lift operation experience.
